Function Information – Sailors' Lounge

Drummoyne Sailing Club boasts spectacular views of Upper Sydney Harbour with 180 degree views from Birchgrove to Hunters Hill across North Sydney, including views of Spectacle, Cockatoo & Snapper Islands.

The large glass enclosed Sailors' Lounge is fully air conditioned & opens onto a large outdoor deck that caters exclusively for the needs of all of your guests. It has its own bar and holds up to 130 guests comfortably for a cocktail party.

The Sailor's lounge is generally available for private function hire on Saturday evenings from 7.30pm – 12 midnight. (Due to the close proximity of neighbours all functions must conclude no later than 12 midnight.)

Drummoyne Sailing Club offers cocktail or buffet style menus to ensure that you have time to enjoy your function. A minimum bar spend of \$1000 is required for all functions. Beverage packages can be pre-arranged.

Terms & Conditions

Confirmation of Booking & Payment Terms

To hold a function at Drummoynesailing Club, you must be a member of the Club (Social Memberships are currently available for only \$20 and are renewable at the start of each financial year). The booking of a function will only be confirmed after a \$500.00 deposit has been paid and the Terms & Conditions returned. All functions are subject to an additional \$500.00 security bond refundable by cheque the following week, where no damage has been incurred to the Club or its' premises and all terms and conditions have been met(21st Birthdays are subject to a \$1000 security bond). Final numbers must be confirmed and all function expenses including security bond, beverage tab, catering and any additional charges paid for in full 10 days prior to the function date. No booking will be permitted for a birthday party of an age younger than 21.

Cancellation

In the event of a confirmed function being cancelled within 30 days of the function date, the \$500.00 deposit initially paid will be forfeited. Where a room is cancelled & more than 30 days notice is given, 80% of the initial bond paid shall be refunded. Written advice is required where any function is required to be cancelled and any applicable refund given shall be determined from the receipt date and not the date of the written notice.

Entertainment

As we are situated in a densely populated residential area, entertainment options are minimal. **Live entertainment of any kind (including DJ's) is not permitted.** Where sound systems or jukeboxes are provided, the volume always remains at the discretion of the duty manager on the day of the function. Personal sound systems or a hired jukebox or entertainment offered by the Club are your only entertainment options.

Loss or Damage to Club Property

1. The client remains responsible at all times for any loss or damage to the Club caused by the client, their caterers and their guests.
2. We are extremely careful when looking after guests and their property. Unfortunately, we cannot take responsibility for damage or loss of items before, during or after a function.

Unacceptable Behaviour & RSA

Drummoynesailing Club is a registered Club and we enforce the regulations set by the Office of Liquor, Gaming & Racing in regards to the Responsible Service of Alcohol. The management reserves the right to remove patrons attending functions where they show signs of intoxication or demonstrate unruly behaviour. Unacceptable behaviour may result in the closure of the function and no refunds will be given. The Club does not permit yard glasses. Double nips & liquor shots are not permitted in functions under any circumstances.

Provision of Goods & Services Supplied by the Client

Delivery of hired or any other equipment supplied by the client to the Club must be advised and arranged in advance with the event co-ordinator and must be delivered to a designated area. Although all care will be taken, the Club will not accept responsibility for the security, set-up, workings or transportation of such equipment and will not accept any responsibility for any loss or damaged sustained. The client agrees to begin the function and have guests vacate the designated function area at the agreed times. The client also agrees to remove any such supplied / hired equipment at a time agreed with by the Club.

Children on the Premises

Children are permitted in the designated function area only. Children must be strictly supervised at all times by a responsible parent or guardian and remain the responsibility of the client. Children are not permitted to use the pool table or approach the bar.

Unforeseen Circumstances

In the event of the inability to comply with any of the provisions of this contract by virtue of any cessation or interruption of essential utilities, industrial disputes, plant or equipment failure, unavailability of food items, other unforeseen contingency or accident, the Club reserves the right to cancel any booking and refund any deposit paid without notice. Alternatively, should the required function area be unavailable, we reserve the right to substitute venues.
